






Ash Grove put Greene County funding to work this year by streamlining city operations with new gWorks software and enhancing safety with a widened bridge and a sidewalk along Maple Lane. The city also celebrated progress on a new fire station, a growing subdivision, and park improvements that included a butterfly bench, stage, and renovations to Killingsworth Hall.

The Silver Springs Pavilion Renovation will service the disproportionately impacted communities of North Springfield by offering a valuable and clean gathering space for community organizations and the general public. Silver Springs Park is one of the oldest parks in Springfield. It dates back to 1919 when it was created as a park for the African-American population due to segregation

For many years it was a key fixture in the recreational life of the city's African-American population. The park was the location for many park district programs, community festivals, picnics, baptisms, and even a semi-professional baseball team. However, there was increasing concern that the park needed improvement and facility upgrades as time has progressed. For many reasons, the renovation has the chance to be transformative for the citizens of Greene County. The renovated pavilion offers upgraded and renovated facilities, including a concession area, pavilion tables, new bathrooms, and amphitheater style seating just outside the pavilion. Community residents are now planning for additional programming which might include such things as a farmer's market, health screenings, community education, children's activities, as well as expansion of services.

The Boys & Girls Clubs of Springfield Teen Center used ARPA funding to assist in financing the construction of the Risdal Family Center for Great Futures. The center will continue to provide traditional services offered at Boys & Girls Clubs: meals, internet access, healthy childhood environments for foster youth in high poverty districts, employment assistance, child care, while pivoting to include first job skills training and career readiness.

The Risdal Family Center for Great Futures provides opportunities for teens to interact with each other through various activities, classes, and programs. Teen interaction in a healthy childhood environment is especially meaningful for youth who are disproportionately impacted by economic struggles or medical difficulties. Potential benefits that can be realized through the family center include improved grades and school attendance, improved social and emotional skills, and a centralized hub for teen needs.

On June 18<sup>th</sup>, 27 employees graduated from a six month journey designed to deepen their understanding of county government. Representing nearly every office in Greene County, this class explored how departments work together and how their roles impact the citizens we serve.

As part of their experience, Class VII studied The Great Game of Business, learning how transparency, collaboration, and open book management can empower employees and build public trust.

But their impact didn't stop there, this class also gave back in a big way through two powerful service projects:

- Packed 588 boxes at Ozarks Food Harvest. That's 14,847 meals for local seniors!
- Organized a supply drive benefiting Victory Mission and Parkview Christian Church's Unsheltered Ministry.






The Budget Office devised a new way of monitoring our financial condition throughout the year by using previous year experience against the new budget levels.

This has also allowed us to project and plan for differing levels of cashflow needed throughout the year. This new tool will be incorporated into the long term planning process.

#### **DID YOU KNOW?**

The 2025 Greene County Budget included more than \$284.6 million in expenditures. The budget process began in July 2024 and was finalized on January 10, 2025.



This location originally had a structure that contained several pipes positioned side by side. After the failure of these pipes and the closure of the structure in August of 2024, it was concluded that the most suitable course of action would be to replace the pipes with a single-span bridge structure.

Original structure was designed by a Greene County Road and Bridge Commissioner and built in 1916. The new structure will be a curved steel girder bridge with 2-lanes instead of a 1-lane, and the design will include a "smoother" curve instead of the existing harsh 90-degree turn. This new bridge will also have guardrail on all four sides.

#### PREPAREDNESS IN ACTION

The Springfield-Greene County Office of Emergency Management (OEM) played a vital role in keeping the community safe and informed throughout the year. The **Emergency Operations Center** was activated three times, Feb. 18, Apr. 29, and Jun. 29, bringing together city and county representatives to respond to winter weather, storm damage and widespread power outages. The Public Information Call Center kept residents connected with real time updates, and damage assessments submitted to FEMA led to disaster declarations, opening the door for financial assistance to small businesses and families. OEM also partnered with the Missouri Baptist Disaster Relief Team to provide meals to those in need until power was restored.

#### PREPAREDNESS IN ACTION

Beyond response efforts, OEM worked to strengthen preparedness in the community. Staff visited schools and local events to teach the next generation about storm safety, including engaging presentations for kindergarten students on how to react when outdoor warning sirens sound. These efforts helped children feel less fearful and more confident in handling emergencies.





OEM also maintained a strong presence during major community events such as Route 66 and the 89th Annual Ozark Empire Fair. With Skylab serving as a mobile command post, OEM and 9-1-1 staff coordinated resources, monitored conditions, and ensured the safety of thousands of attendees. From daily safety briefings to on-scene response capabilities, their work kept festivals running smoothly and safely for all.

#### **PROJECTS AROUND CAMPUS:**

Judicial Courts Facility Secured Entrance: Construction began in March of 2025 on a new building that will serve as a secured entrance and connect the Greene County Judicial Courts Facility and former Sheriff's Office and Jail on Boonville Ave in Springfield. It will become the main entrance to both buildings as Campus Security will have their screening equipment to screen the public before wayfinding signs direct the public to which building they should enter. The offices for the Pre-Trial Services Department will also move into this building. This is scheduled to be complete in fall of 2026.

Construction of a new Treatment Court was completed in January 2025 in the former Sheriff's Office space in the southwest corner of the ground floor of the Judicial Courts Facility. Additionally, renovation of the Juvenile Detention Center on Robberson Ave was completed in July of 2025 which houses more secure rooms.



Historic Courthouse Renovations: 1. Construction of customer service counters in the west area (Room 39) of the Assessor's Office started in May 2025. This will be moving from the center area (Room 37) which will now become office space. 2. Women's restrooms on the 2nd and 3rd floors were added and the adjacent men's restrooms on those floors were also renovated.

### CUSTOMER SERVICE IMPACT

On average, staff assist 35,000 walk-in customers and handle 25,000 phone calls annually. In 2025, these numbers rose significantly due to the new City of Springfield expired tag ordinance, which led to:

- 73% increase in customer traffic in March 2025 compared to March 2024
- 41% overall increase in customer volume compared to 2024



The Circuit Clerk's Office celebrated the completion of a two year project where more than 50 Clerks and Judges worked diligently and led the state by completing over 9500 expungements of specific marijuana cases, as required by a 2022 constitutional amendment. There were grand jury indictments filed this year at the 31st Judicial Circuit Court for the first time since 2018.

#### **AWARDS AND ACHIEVEMENTS**

At the annual Judicial Conference of Missouri in Branson on September 18, 2025, Missouri Supreme Court Powell Chief Justice W. Brent presented the Judicial Excellence award for Circuit Judges to Presiding Judge Jerry Harmison of the 31st Judicial Circuit (Greene County). The annual award recognizes significant contributions to the advancement of administration of justice Judge Powell Missouri. Harmison was recognized as a leader in the greater Springfield community even before becoming a judge, as he previously served as the president of Springfield School chairman of the board for the Springfield Area Chamber Commerce, and president of the board for Care to Learn.



Judge Powell stated, "as a judge, Jerry has displayed new depths of leadership." In a recent time of change and transition in the Greene County Circuit Court with vast turnover on its bench, "Harmison has been a steady hand at the helm, steering his circuit court forward while treating parties, jurors, and colleagues alike with fairness and respect."



Greene County ran four elections in 2024, including a June 18 runoff. Actual costs came in under estimates for every election, ranging from \$21.9k (June runoff) to \$648.7k (November general). The office staffed 600+ election workers, operated 80 precinct sites plus 5 countywide "central" sites, and split several precincts to reduce congestion. Operational upgrades included a 6 week preelection call center, activation of Emergency Management support on Election Day, and deployment of 20 Poll Print ballot-on-demand units.



Turnout and registration rose: the Nov. 5, 2024 General saw 69% of active voters participate with 85 polling places and 632 judges. A total of 145,848 ballots, being 44,417 absentee. Over the year, the office registered 15,027 new voters, processed 49,154 address and name changes, mailed 165,912 voter ID cards, trained 64 deputy registrars, and verified 154,109 petition signatures. Registered voters reached 217,719 by Dec. 31, 2024.

# HIGHLIGHTS

In 2024, the Collector's Office took on an important new responsibility with the launch of the Senior Tax Credit program. This initiative allows eligible homeowners aged 62 and older to "freeze" certain portions of their property tax bills. Once qualified, reassessment increases are offset by a tax credit that helps seniors better manage rising costs. The response has been

significant. In its first year, the Collector's Office processed more than 15,000 applications, and by 2025, another 5,000 applications had been submitted. The program has quickly become a vital resource for thousands of Greene County residents seeking stability and peace of mind.

#### DID YOU KNOW?

Senior Tax Credit Program Launched in 2024. The program helps eligible seniors manage rising property taxes. The Collector's Office has already processed over 20,000 applications in its first two years.



The Recorder's office completed the Digitization Project, which consisted of 90 historic deed books. All images are now accessible in office by computer, saving wear and tear on delicate books. Plans are in place to continue indexing remaining records, making more available for electronic research.



Over 800 Greene County property owners have enrolled in our free Property Notification Alert System. This allows citizens to monitor their name and to receive email notifications when any document is recorded.



#### **VEHICLE SAFETY GATEWAY:**

Over the years, the **Greene County** Sheriff's Office has dealt with a number of near-misses and suffered the devastating loss of two deputies to vehicle related accidents. We have long searched for a way to better protect our deputies and the public on the road, and we found a solution. The Greene County Sheriff's Office has equipped our patrol fleet with an innovative piece of technology called the Vehicle Safety Gateway (VSG).

This cutting-edge technology is integrated into the Whelen Engineering equipment installed in our patrol vehicles and uses the HAAS Alert system to communicate to other vehicles. The VSG interfaces with our patrol car emergency lights, sirens, and other vehicle functions.

One capability of the VSG is responder-to-responder alerting. In situations where two patrol cars are responding to emergencies and may potentially intersect, the system alerts the deputies driving the vehicles. This ensures heightened awareness and safety for our deputies in emergency response.

Another capability of the VSG is its public alerting feature. This function interfaces with traffic and navigation apps such as Waze, Apple Maps, Stellantis, and others. It enables the public to receive notifications on these platforms regarding an emergency vehicle's presence, whether it's responding with lights and sirens or already on scene.

These advanced features are part of our dedication to enhancing the safety of both the community and our deputies, whether during emergency response or on-scene situations. Our commitment to safety extends to all aspects of our duties, and we continually strive to identify and implement the most effective ways to serve our community.

#### DID YOU KNOW?

The Greene County Sheriff's Office has launched a free mobile app on the Apple App Store and Google Play Store. The app gives users quick access to jail information, inmate search tools, the community resource guide, anonymous crime tip submissions, and contact information. It also includes a public alert system, sending critical updates directly to mobile devices. Search "Greene County Sheriff MO" to download.






